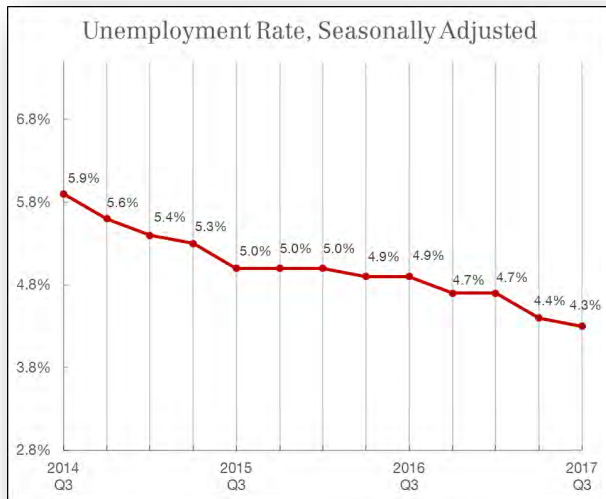

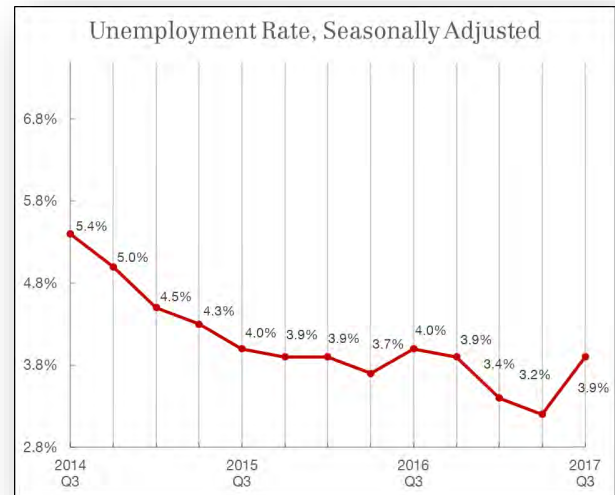

Average occupancy rates in West Michigan markets have increased from 95.48% (Q2 2017) to 95.85% (Q3 2017).

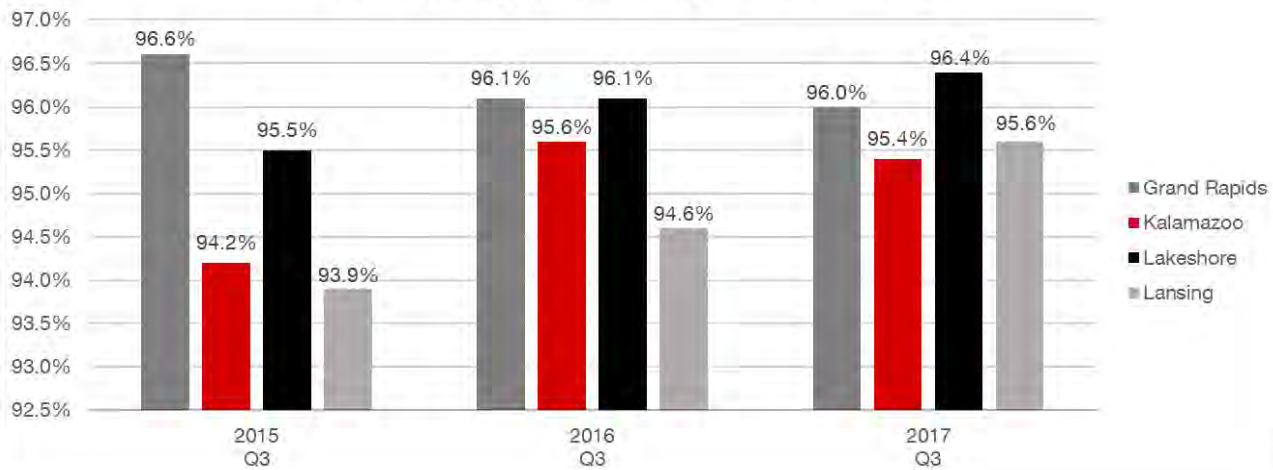

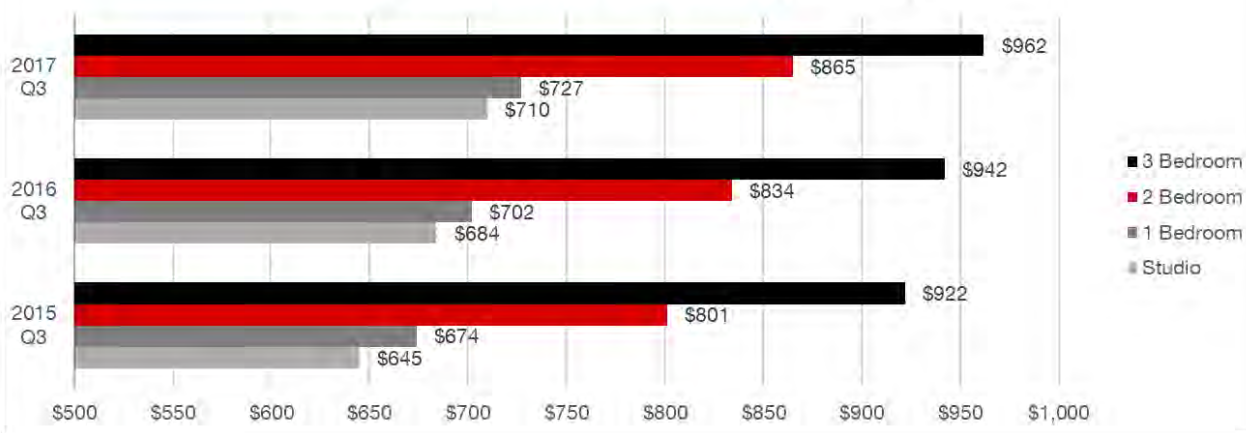

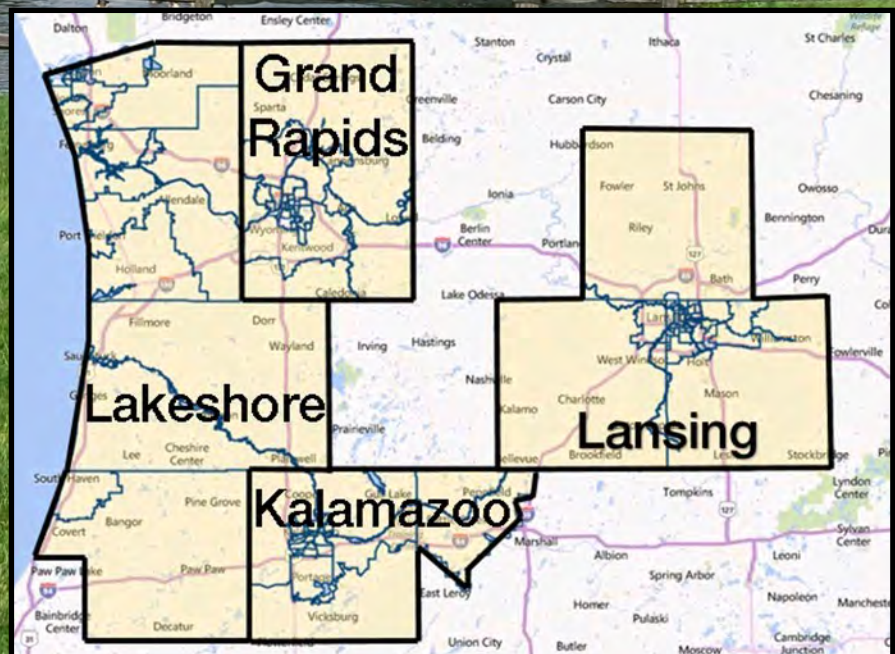
